GIFTS FOR UNRESTRICTED SUPPORT OF THE UNIVERSITY OF WISCONSIN – MADISON:

I hereby give, devise and bequeath to the University of Wisconsin Foundation, a non-profit, non-stock Wisconsin corporation with principal offices in Madison, Wisconsin _____ percent (_____%) of the rest, residue and remainder of my estate (or, alternately, the sum of \$_____) for the unrestricted benefit of the University of Wisconsin-Madison.

GIFTS TO CREATE A PERMANENT ENDOWMENT FUND FOR UNRESTRICTED SUPPORT OF THE UNIVERSITY OF WISCONSIN – MADISON:

I hereby give, devise and bequeath to the University of Wisconsin Foundation, a non-profit, non-stock Wisconsin corporation with principal offices in Madison, Wisconsin _____ percent (_____%) of the rest, residue and remainder of my estate (or, alternately, the sum of \$ _____) to create a permanent endowment fund that should be invested and managed according to the Foundation's standard procedures for such funds. The fund should be named the _____ Endowment Fund and any distributable amounts from this fund should be used to fund faculty support in the Department of _____ in the _____ (Insert the appropriate name of the College, School or Division) _____ at the University of Wisconsin-Madison. It is the intention that these funds should be used to recruit and retain the best and brightest faculty at the University and depending on the size of the gift, the awards may be referred to a faculty support funds, a professorship, or a chair. Appointments should be made by the usual process currently in place at the University at any given time. Should the purpose for which the Fund is instituted become impossible to perform or impractical to the extent that

the Foundation is unable to use the support generated by the Fund under the existing terms for five (5) consecutive years, and if, at that time it is impossible or impractical to consult on a modification of the Fund terms with the Donors' surviving family members, the Foundation, through a resolution passed by its Board of Directors, may devote the Fund to other purposes as close to the Donors' original intent as it can at that time devise. In any such modification, the fund shall remain a permanent endowment fund and continue to use the name identified in this provision.
